This Akita will be co-owned between the purchaser and Celestial Akitas until this Akita is a champion of record and the purchaser fulfills the following terms:

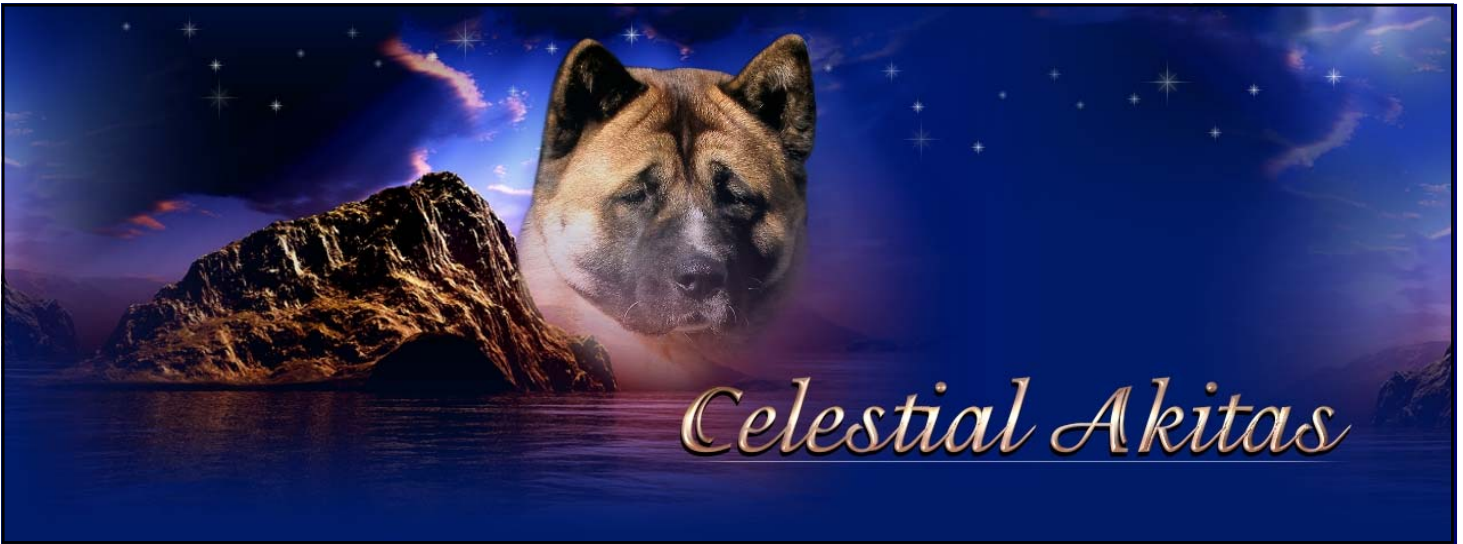
MALE TERMS

_____ Stud right's are used by Celestial Akitas to any female Celestial Akitas own, co-owns or leases. A stud right is defined as the breedings necessary to produce two (2) or more live puppies at eight (8) weeks of age from one litter.

If Celestial Akitas collects semen for freezing, it will be done at Celestial Akitas expense and the collection will be considered one of the Stud Rights. Any semen that is collected and stored by Celestial Akitas is considered the property of Celestial Akitas with all rights thereof and client agrees to relinquish all rights to such semen.

Celestial Akitas may opt for a puppy back from approved bitch using this stud dog instead of the stud rights named above. _____ (initial)

This Akita cannot be neutered without written agreement from Celestial Akitas, except in the case of medical emergency. _____ (initial)



FEMALE TERMS

_____ Puppies back is/are received by Celestial Akitas. Celestial Akitas must approve the sire of puppies. A puppy back is defined as a puppy chosen by Celestial Akitas between the ages of 7 ½ and 8 ½ weeks of age. Celestial Akitas has the responsibility of transportation of said puppy. Client must provide a thorough videotape of the entire litter, and cannot place any puppy until Celestial Akitas decides on the puppies back:
