1) Celestial Akitas guarantees to the best of our knowledge that the above Akita is of sound body, good health and free of any communicable disease at the time of sale/ placement with buyer. Buyer understands they should take said Akita to the veterinarian of their choice within 72 hours (3 days) of purchase, if animal is found to be unsound or unhealthy it may be returned to us (Celestial Akitas) at buyer's cost, for a full refund of the purchase price.

2) Akita will be registered with the prefix "Celestial" on the AKC registration papers. As long as Akita stays with the original owner(s) this Akita will be guaranteed up to the age of three (3) years to be free of any genetic disease that claims the life, causes serious handicap, or claims the sight (blindness) of the Akita. It must be the result of genetic origin and not the result of environmental factors (poor nutrition, accident, or illness) after the client/ buyer has taken possession of this Akita. If the Akita is found to have a genetic disease, to extent mentioned above, it will be replaced with an Akita of equal quality (companion) as soon as one becomes available. Replacement will occur only when written confirmation of condition/ euthanasia (only if disease warrants) of said Akita has been received by Celestial Akitas from your veterinarian on their letterhead. _____ (initial)

3) Buyer understands that said Akita is being sold as a companion and as such does not have breeding privileges, and that AKC papers will be retained until such time as sterilization (spayed/ neutered) is confirmed by a licensed veterinarian on their letterhead. At that time, AKC papers will be released with LIMITED REGISTRATION/ NO Breeding privileges. (Limited registration means dog may participate to obtain titles listed below in section 5, and Celestial Akitas encourages participation in title/ rebate program.) If buyer is unable to keep said Akita, they MUST contact Celestial Akitas for first right of refusal to obtain Akita back. Buyer also agrees to keep Celestial Akitas informed of any change of address, telephone number or email address.

4) Buyer agrees to provide regular veterinary care, quality food, adequate water, companionship and proper exercise. Buyer also agrees to maintain Akita in a properly fenced yard or kennel run with appropriate shelter when not in the home with the "family" and at no time will the animal be chained or turned loose to run the neighborhood.

- a) Basic obedience class graduation with certificate (copy must be presented) \$15.00
 - b) Initial titles including AKC, UKC or CKC obedience, tracking, or agility (copy must be presented) \$50.00
Each subsequent title in obedience, tracking, or agility \$10.00 (copy presented)
 - c) Registered/ certified therapy dog \$50.00
 - d) TT (Temperament test) copy of certificate required \$25.00
 - e) CGC (canine good citizen) copy of certificate required \$10.00

6) By signing and initialing this contract buyer understands he/she is solely responsible for this Akita and indemnifies and holds harmless Celestial Akitas from any and all claims of liability for the conduct of this Akita on or after the date of this contract. _____ (initial)

7) We like to be kept informed on all the animals we sell, they are a part of us and we would like to be kept up to date on them from time to time. A note and a picture is always appreciated. If we find out this dog has been abused in ANY shape, form or fashion and it is confirmed by Animal Control, Humane Society, or Police it WILL be re-possessed and you will receive NO REIMBURSEMENT. By signing this contract you are accepting these conditions and understand you are giving us legal right to re-possess this dog.
